

PRIVACY POLICY – SKIPASS ISSUE

Pursuant to Art. 13 of Regulation (EU) 679/2016 on the protection of personal data (GDPR), PromoTurismoFVG provides information regarding the processing of personal data provided in relation to the skipass issue service.

Data Controller

The Data Controller is PromoTurismoFVG with registered office in Via Locchi 19 - 34123 – Trieste, administrative and operational headquarters in Via della Vecchia Filatura 10 – 33035 Torreano di Martignacco (UD) and marketing headquarters in Via Carso 3 – 33052 – Villa Chiozza, Cervignano del Friuli (UD), VAT No IT01218220323 and Tax Code 01218220323. The Data Controller has appointed a Data Protection Officer (DPO), whose contact details can be found on the website <http://www.promoturismo.fvg.it/> or at the administrative offices of PromoTurismoFVG.

Purpose and legal basis of the processing

PromoTurismoFVG collects and processes with paper or electronic tools the personal data necessary for the purchase and issue of ski passes. Specifically, it processes a series of identification data of the User, such as name, surname, date of birth, email, address of residence, postcode, city and country of origin, document certifying family status (where applicable), updated photograph of the ski pass holder, proof of eligibility in case of concessions and discounts. Such data, possibly also referring to members of your family, shall be processed by PromoTurismoFVG for purposes related to the management of the contractual relationship, the collection of data contained in the ski pass in the ski lift access area, verification of the existence and validity of the contractual requirements for the ski pass holder and for statistical purposes.

Data are lawfully processed without the user's consent insofar as they are necessary to execute a contract (Art. 6(1b) of Reg. (EU) 679/2016) or because the processing is required by law (Art. 6(1c) of Reg. (EU) 679/2016).

The data shall never be disseminated, and may be processed by PromoTurismoFVG suppliers, duly appointed as data processors, for purposes essential to providing the contractual service. Furthermore, pursuant to Art. 130(4) of Legislative Decree 196/2003, unless the user expressly objects by notifying PromoTurismoFVG, it is possible that in the future the user may receive further messages relating to services similar to those used or requested. At any time, the user may choose to no longer receive such messages by clicking on the “unsubscribe” link contained in each message received.

Recipients of personal data

Please note that the personal data provided shall be processed by the Data Controller in a lawful, correct and transparent manner (Art. 5 GDPR). If necessary, the data provided may also be processed by third parties, who carry out activities that are instrumental or connected to the Service requested or to other requests made by you. Third parties act as Data Processors pursuant to Art. 28 of Reg. (EU) 679/16.

Data retention and data transfer

The data provided shall be kept for as long as you use the services made available by PromoTurismoFVG, unless otherwise required by law. Data shall not be transferred outside of the EU.

Rights of the data subject

At any time, it is possible to exercise the rights provided for in Articles 15 et seq. of the GDPR by contacting the Data Controller or the Data Protection Officer (DPO). The specific form for exercising these rights can be found in the privacy section of the website.
